BY LAWS

John Johnson will submit a recommendation that the By-Laws be modified to state simply that JCAG is made up of Georgia Independent Juvenile Courts, rather than listing a particular number of courts as it does now. The

reason for this is that the number of independent courts fluctuates from year to year. We will vote on this change at a later session. In light of this, although we do have printed and PDF copies of the by-laws John would like to find out who has the original copy so that we will not have to retype the entire document when modifications are made.

FUNDRAISING

John reminded us again that all of the current information is on the website.

WEBSITE

John stated that the website is being updated as we go.
